The Grand Jurors for the State of Tennessee, upon their oaths, present that JOSHUA ROBERT SMITH, ALIAS, on or between the 25th day of February, 2017 and the 8th day of February, 2019, in Knox County, Tennessee and before the finding of this presentment, did unlawfully and knowingly obtain or exercise control over property, to-wit: United States currency, of the value of at least \$2,500.00 but less than \$10,000.00, of City of Knoxville without its effective consent, with intent to deprive the said City of Knoxville thereof, in violation of T.C.A. § 39-14-103, and against the peace and dignity of the State of Tennessee.

#### SECOND COUNT:

The Grand Jurors for the State of Tennessee, upon their oaths, present that JOSHUA ROBERT SMITH, ALIAS, on or about the 25th day of February, 2017, in Knox County, Tennessee and before the finding of this presentment, did unlawfully and knowingly, and with intent to defraud or harm City of Knoxville of the value of at least \$2,500.00 but less than \$10,000.00, forge and make without the authorization of said City of Knoxville certain writings by making false entries in the books or records of said City of Knoxville, in violation of T.C.A. § 39-14-114, and against the peace and dignity of the State of Tennessee.

#### THIRD COUNT:

The Grand Jurors for the State of Tennessee, upon their oaths, present that JOSHUA ROBERT SMITH, ALIAS, on or about the 25th day of February, 2017, in Knox County, Tennessee and before the finding of this presentment, did unlawfully and knowingly, while a public servant, and with the intent to obtain a benefit violate a law relating to said defendant's office or employment, in violation of T.C.A. § 39-16-402, and against the peace and dignity of the State of Tennessee.
