THE GRAND JURORS of Tipton County, Tennessee, duly empaneled and sworn, upon their oath, present that DANIEL WILLIAM JACOBS, on or about June 10, 2021, in Tipton County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously and knowingly, while a public servant, with intent to obtain a benefit or receive a benefit not authorized by law, and by acquiring nonpublic information derived from his position as a public servant or gained from his performances of his official duties as a public servant, knowingly act on such nonpublic information to acquire a 2010 Lincoln MKZ automobile with intent to make a profit, in violation of T.C.A. 39-16-402(a)(5)(c)(1)(B), against the peace and dignity of the State of Tennessee.

COUNT 2

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about June 10, 2021, before the finding of this indictment, the said **JACOB ANTHONY GARDNER AND DANIEL WILLIAM JACOBS**, did unlawfully, feloniously and knowingly, with the intent to deprive the owner of a 2010 Lincoln MKZ automobile, attempt to obtain said automobile without the effective consent of said owner, to-wit: Tipton County Sheriff's Office, said automobile being of a value of over two thousand five hundred dollars (\$2,500), but less than ten thousand dollars (\$10,000), in violation of T.C.A. 39-14-103 and T.C.A. 39-12-101, against the peace and dignity of the State of Tennessee.

COUNT 3

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about June 10, 2021, before the finding of this indictment, the said **DANIEL WILLIAM JACOBS**, did knowingly, directly or indirectly, access a computer for the purpose of obtaining property of a value of over two thousand five hundred dollars (\$2,500), but less than ten thousand (\$10,000) for himself or another by means of false or fraudulent pretenses, in violation of T.C.A. 39-14-602(a)(1), against the peace and dignity of the State of Tennessee.
